Location: Mother Lode Fairgrounds, 220 Southgate Drive, Sonora, CA 95370

Dates/Times: Thursday, September 19, 2024 10am to 5pm (vendor set up)
Friday, September 20, 2024 9am to 4pm (show open)
Saturday, September 21, 2024 9am to 4pm (show open)

Booth space size: Single booth: 10 ft. deep by 10 ft. wide with two 8 ft. tables and 2 chairs.
Double booth: 10 ft. deep by 20 ft. wide with four 8 ft. tables and 2 chairs.

Booth rental fees: \$140 per single booth; \$280 per double booth.

Payment schedule: Signed contract and total fee amount are due no later than June 1, 2024.

This fee is non-refundable. Unless the show is cancelled due to covid. *If you find you are unable to attend please let us know immediately and we will try to fill your space.*

Terms of agreement:

1. Unloading prior to stated opening time and packing prior to the stated closing time is not permitted.
2. The guild and its members and the leaser/owner, their agents and employees, shall be held harmless by the vendor for any harm, including but not limited to, injury, loss, theft, damage, or false arrest.
3. The guild retains the right to change or add provisions in the interest of the safety or the protection of the property.
4. This contract is non-transferable.
5. Due to state and local Health Department Regulations, animals are not permitted in the buildings.
